# **Resolved Issues**

The following issues have been resolved in this release.

Case Number	Apttus Internal ID	Description
N/A	ASSETS-2175	When you renewed the quote manually, Apttus CPQ created a new Renewal Quote instead of updating the existing quote.
CAS-02962- K6D7P9/ CAS-04674- L5L7X8	CPQ-34613 / CPQ-35054	When you defined attribute value matrices for a bundle and its options with the same attribute group associated to them, Attribute Value Matrix delayed in updating the attribute values in the attribute groups for the option on the Configuration page. This happened when Cascade Shared Attribute Updates is enabled.
N/A	CPQ-35556	When an Exclusion Constraint Rule executed via an API was violated, Apttus CPQ did not display the warning icon (red exclamation mark) on the line item on the Cart page.
N/A	CPQ-36635	On the Configuration page, Apttus CPQ did not hide the option group with <b>Is Hidden</b> checkbox selected.
N/A	CPQ-36712	When you clicked <b>Revalidate</b> on the Cart page, Apttus CPQ displayed an error.

The following table lists the known issues resolved from the previous release.

Apttus Internal ID	Description
ASSETS-259	When you changed an asset on the Installed Product page, Apttus CPQ did not update the <b>Total Quantity</b> on the Cart page.
ASSETS-164	Renewal Quote must drop lines post Change: Config instead of updating on existing Renewal quote because the "Changed Config" asset is no longer eligible for further Renew.
	This issue was closed because the customer could still use this behavior for forecasting and mark the opportunity lost for later purposes.
CPQ-36301	In Angular Cart, you were only allowed to perform the <b>Delete</b> action when you selected a line item that was being submitted to the collaborator. This happened when the cart was displayed in the grouped mode.
CPQ-33710	With Allow Manual Adjustment set to False, Apttus CPQ allowed you to apply adjustment through the <b>Multiple adjustment</b> popup.
CPQ-14793	When you ran the Category Maintenance batch job for a large number of categories, Apttus CPQ displayed an error.

Apttus Internal ID	Description
CPQ-34291	When you selected a location in the <b>Selected Location</b> filter on the catalog page, the cart did not filter product.  This issue was closed because it was an invalid issue.
CPQ-34889	When all options of an option group were hidden with exclusion rule, the option group remained visible until you clicked <b>Validate</b> .
CPQ-34953	Default Queue name from Junction object was not getting defaulted in the Collaboration popup.  This was not supported as custom lookup cannot be created to Queues.
CPQ-36030	When the product that needed approval was deleted from the cart, the <b>Finalize</b> button was not enabled and the <b>Submit for Approval</b> button was not disabled.

### **Known Issues**

The following table provides the cumulative list of known issues up to this release.

Apttus Internal ID	Issue
ASSETS-2591	On the Renewal Quote, Apttus CPQ displays incorrect quantity for existing Assets Line.
ASSETS-2574	Values are not proper for flat price incremented and merged lines on the user interface popup for the Projected Asset Value API.
ASSETS-2568	The order is not generated when <i>Quantity</i> or <i>Selling Term</i> is added to the Selected Purchase Identification Criteria in Purchase Identification Criteria.
ASSETS-2507	When you define the Config Asset Pricing Default setting to override a specific line status, Apttus CPQ overrides all line statuses.
ASSETS-1769	Asset Pricing does not work properly for Asset without attributes when asset pricing criteria have some attribute API defined for other assets.
ASSETS-1724	Config asset pricing criteria are not functioning on a single ramp renewed line (renew one ramp = true).
ASSETS-1636	After you have renewed an asset with a one-time primary line when you perform <b>Change:</b> Config action, an incorrect Delta Price and Net Price are calculated on the cart.
CPQ-11829	If the option group is single-select and requires the selection (min:1, max:1), you cannot make it optional from the configuration page but can make it optional from the cart. You can notice the same behavior when options required by default.
CPQ-15170	When you add ramp with a price escalator, the added price ramp lines get the base price of previous ramp line rather than the latest one.
CPQ-33607	If you manually select mandatory options after deselecting them, Apttus CPQ displaysoptionalcheckbox. Ideally, Apttus CPQ hides optional checkboxes for mandatory options.
CPQ-35115	When you search for a product in the cart grid that has more than 1 page, the cart does not display any result when the product is not on the same page. However, cart displays the search result when you navigate to the page where the product is listed.
CPQ-35401	When you click <b>Generate</b> to create a proposal document, the <b>Preview</b> section does not load the generated document when the <b>Enable File</b> field in Proposal System Properties is selected.
CPQ-35405	When the Smart Search setting is active in the Config Setting, the catalog page does not display the Refine Your Search filter for Search Category Defaults Top Categories, All Categories, and All Products.

Apttus Internal ID	Issue
CPQ-35448	In an Inclusion Prompt Constraint Rule, if the field <b>Match in Assets</b> is selected for the asset (bundle) in the Constraint Rule Action, when you add a Constraint Rule Condition bundle to the cart, ideally the cart does not display inclusion prompt and the wrench icon beside the condition bundle. But, the wrench icon is displayed and because of this, you cannot finalize the cart.
CPQ-36242	On the Cart Grid, Apttus CPQ does not display line items completely. This happens when you only have one line item in the cart and <b>Enable Contextual Totals</b> is selected in Config System Properties.
CPQ-36655	On the Service Cart page, Apttus CPQ does not calculate correct <b>Weightage Amount</b> when <b>Weightage type</b> is <i>Percentage</i> .
