## Resolved Issues

The following table represents the issues resolved in this release.

| Case Number | Apttus Internal ID | Description   |
|-------------|--------------------|---|
| N/A         | CPQ-35671          | In the CPQ Admin when you defined Min as 0 while creating a constraint rule action, Apttus CPQ did not allow you to save. This happened when you defined <b>Action Intent</b> as Prompt and <b>Min-Max Match Rule</b> as <i>Include Min/Max</i> . |
| N/A         | CPQ-36458          | On the Catalog page, when you scrolled up or down the screen flickered. This happened when the catalog only had 3 products.   |
| N/A         | CPQ-36472          | On the Cart page, rows of the adjacent columns were not aligned correctly when the cart had a large number of line items. You saw the misaligned rows when you scrolled horizontally and/or vertically.   |

The following table lists the known issue resolved from the previous release.

| CPQ-33710          | With Allow Manual Adjustment set to False, Apttus CPQ did not allow you to apply adjustment through <b>Multiple adjustment</b> pop-up.       |
| CPQ-35202          | When you dragged and dropped a line item in the cart after notifying collaborators, the position of <b>Collaboration</b> icon was misplaced. |
| CPQ-35203          | In the cart grid, the <b>Grand Total</b> line is not visible when <b>Enable Contextual Totals</b> in Config System properties is selected.   |



## Known Issues

The following table provides the cumulative list of known issues up to this release:

| Apttus Internal ID | Description  |

| ASSETS-1636        | After you have renewed an asset with a one-time primary line, when you perform the <b>Change: Config</b> action, incorrect Delta Price and Net Price are calculated on the cart.   |
| ASSETS-1724        | Config asset pricing criteria do not work when Renew One Ramp is selected.   |
| ASSETS-1769        | Asset Pricing does not work properly for Assets without attributes when the asset pricing criteria have an attribute API defined for other assets.   |
| CPQ-11829          | If the option group is single-select and requires the selection (min:1, max:1), then you cannot make it optional from the configuration page but can make it optional from the cart. You can notice the same behavior when options required by default.      |
| CPQ-12336          | Rollup data get auto-generated when incentives are saved for the first time. You can make additional changes directly on the roll-up record. These subsequent changes should not be overwritten when the incentives are saved again.                         |
| CPQ-14793          | When you runCategoryMaintenance batch job for a large number of categories, Apttus CPQ displays an error.  |
| CPQ-33607          | If you manually select mandatory options after deselecting them, Apttus CPQ displays optional checkbox. Ideally, Apttus CPQ hides optional checkboxes for mandatory options.   |
| CPQ-34889          | When all the options of an option group are hidden with exclusion rule, the option group remains visible until you click <b>Validate</b> .   |
| CPQ-34953          | Default Queue name from Junction object is not getting defaulted in the Collaboration pop-up. This is not supported as custom lookup cannot field be created to Queues.  |
| CPQ-35035          | In the Cart Grid, when any line item is marked as <b>Is Read Only</b> , the cart page disables the <b>Select all</b> checkbox.   |
| CPQ-35115          | When you search for a product in the cart grid that has more than 1 page, the cart does not display any result when the product is not on the same page. However, cart displays the search result when you navigate to the page where the product is listed. |
| CPQ-35260          | With the custom setting 'Expand Bundles in Cart', the number of items displayed per page does not match the 'Items per Page' setting.<br>Pagination feature is not supported along with 'Expand Bundles in Cart'.  |

| CPQ-35401             | When you click <b>Generate</b> to create a proposal document, the <b>Preview</b> section does not load the generated document when <b>Enable File</b> field in Proposal System Properties is selected.  |
| CPQ-35405             | When the Smart Search setting is active in the Config Setting, the catalog page does not display <b>Refine Your Search</b> filter for Search Category Defaults <b>Top Categories, All Categories,</b> and <b>All Products.</b>  |
| CPQ-35448             | In an Inclusion Prompt Constraint Rule, if the field <b>Match in Assets</b> is selected for the asset (bundle) in the Constraint Rule Action then, when you add a Constraint Rule Condition bundle to the cart, idly the cart does not display inclusion prompt and the wrench icon beside the condition bundle. But, the wrench icon is displayed and because of this, you cannot finalize the cart. |
