## Resolved Issues

The following table represents the issues resolved in this release.

Case Number	Apttus Internal ID	Description
N/A	CPQ-36995	Apttus CPQ did not calculate the correct price when you added a service bundle to the service cart. This happened because Apttus CPQ retrieved incorrect prices from the price matrix defined for that bundle.
CAS-11407-N4W3P5	CPQ-37066	On the Cart page in the Lightning mode, Horizontal scroll bar was not visible.
N/A	CPQ-37068	When you had multiple products that required revalidation, if you applied revalidation on one product on the Cart page, Apttus CPQ automatically applied the revalidation on all the products.
CAS-07403-C6F4S6	CPQ-37069	When you modified or deleted a cart view on the Cart Grid, Apttus CPQ deleted all the views with names starting with the same name as the view you modified or deleted.
CAS-11228-D3V8Q4	CPQ-37075	On the Cart Grid when you minimized the browser, scroll bar was not working.

The following table lists the known issue resolved from the previous release.

Apttus Internal ID	Description
CPQ-36978	When you split a service bundle having service option, the weightage amount at option level did not divide equally. This behavior was observed when the Service Price Distribution Method was set to <i>Rollup</i> .
CPQ-37000	After you split the service bundle having an option, the <b>Related Line Items</b> link for the cloned service option was not displayed on the cart page.



## Known Issues

The following table provides the cumulative list of known issues up to this release:

Apttus Internal ID	Description
ASSETS-1636	After you have renewed an asset with a one-time primary line, when you perform the <b>Change: Config</b> action, incorrect Delta Price and Net Price are calculated on the cart.
ASSETS-1724	Config asset pricing criteria do not work when Renew One Ramp is selected.
ASSETS-1769	Asset Pricing does not work properly for Assets without attributes when the asset pricing criteria have an attribute API defined for other assets.
CPQ-11829	If the option group is single-select and requires the selection (min:1, max:1), then you cannot make it optional from the configuration page but can make it optional from the cart. You can notice the same behavior when options required by default.
CPQ-33607	If you manually select mandatory options after deselecting them, Apttus CPQ displays an optional checkbox. Ideally, Apttus CPQ hides optional checkboxes for mandatory options.
CPQ-34889	When all the options of an option group are hidden with exclusion rule, the option group remains visible until you click <b>Validate</b> .
CPQ-35035	In the Cart Grid, when any line item is marked as <b>Is Read Only</b> , the cart page disables the <b>Select all</b> checkbox.
CPQ-35115	When you search for a product in the cart grid that has more than 1 page, the cart does not display any result when the product is not on the same page. However, cart displays the search result when you navigate to the page where the product is listed.
CPQ-35401	When you click <b>Generate</b> to create a proposal document, the <b>Preview</b> section does not load the generated document when <b>Enable File</b> field in Proposal System Properties is selected.
CPQ-35405	When the Smart Search setting is active in the Config Setting, the catalog page does not display <b>Refine Your Search</b> filter for Search Category Defaults <b>Top Categories</b> , <b>All Categories</b> , and <b>All Products</b> .
CPQ-35448	In an Inclusion Prompt Constraint Rule, if the field <b>Match in Assets</b> is selected for the asset (bundle) in the Constraint Rule Action then, when you add a Constraint Rule Condition bundle to the cart, idly the cart does not display inclusion prompt and the wrench icon beside the condition bundle. But, the wrench icon is displayed and because of this, you cannot finalize the cart.
CPQ-36655	On the Service Cart page, Apttus CPQ does not calculate correct <b>Weightage Amount</b> when <b>Weightage type</b> is <i>Percentage</i> .

Apttus Internal ID	Description
CPQ-36873	On the Service Cart page, <b>Service Base Price</b> column is not populated. This happens when you add a service bundle to the cart directly from the catalog page or you configure the bundle first but do not select any options.
CPQ-36980 / CPQ-37111 / CPQ-37122	<b>Add/Remove at all levels</b> feature is not supported in this patch
