This behavior was observed when Renew One Ramp was enabled in the Installed Product settings and Price Ramps were also enabled for the bundle.</p> <p>This issue is now resolved. The Asset Grid retains renew ramp line upon Change or Renew operation after you enable Renew One Ramp and renew of option.</p>	ASSETS-2300

The following issues have been resolved from the previous release:

Apttus Internal ID	Description
ASSETS-1603	When you perform Renew action for a bundle product and deselect an option, incorrect Net Price for option and incorrect rollup price bundle is calculated on the cart.
CPQ-15298	After you apply a promotion to the product on the cart, the Incentive Code is missing on the cart line item.
CPQ-18587	For the custom setting Related Price Scope set to Cart, adding a bundle containing two options with related pricing calculates an incorrect price for the related option products. This was observed when you add the same bundle twice to the cart.
CPQ-34356	When you enable the Auto Reprice for the cart comprising standalone as well as bundle product, Apttus CPQ shows incorrect values unless you reprice the cart line items.
CPQ-34372	For Group Adjustment Spread, net price of bundle product with option checkbox is selected, turns to 0 when you apply discount.
CPQ-34374	For Group Adjustment Spread, adjustment is getting removed from the standalone product when repriced.

Apttus Internal ID	Description
CPQ-34 605	Auto included product's charge type or price is not coming in collaborator's cart. Hence, Collaborator needs to Reprice to view it.
CPQ-34 582	Apttus CPQ does not apply the selected location for line item from the cart when you set "Lookup Record Limit" through Lookup Field Settings.
CPQ-34 583	In case of duplicate entry in Config System Properties > Group by fields, Apttus CPQ shows duplicate products for the cart groups created with those fields.
CPQ-34 670	Product selection is not working as expected after MassUpdate, when option chunk size is set to 1.

Known Issues

The following table represents known issues on this release.

Apttus Internal ID	Description
ASSETS-1636	After you have renewed an asset with a one-time primary line when you perform Change: Config action, an incorrect Delta Price and Net Price is calculated on the cart.
ASSETS-1641	During Terminate action, the system retains originally discounted price for an option product, although the option price got changed on Change action.
ASSETS-1647	Renewal Quote should drop lines post Change: Config instead of updating on existing Renewal quote as "Changed Config" asset is no longer eligible for further Renew.
ASSETS-1724	Config asset pricing criteria are not functioning when single ramp renewed line (renew one ramp = true).
ASSETS-1769	Asset Pricing does not work properly for Asset without attributes when asset pricing criteria have some attribute API defined for other assets.
CPQ-7272	You are able to apply same coupon for more than once in order to give incentives.
CPQ-11829	If the option group is single select and requires the selection (min:1, max:1) , then you cannot make it optional from the configuration page but can make it optional from the cart. You can notice the same behavior when option is required by default.
CPQ-12336	Rollup data get auto-generated when incentives are saved for the first time. You can make additional changes directly on the roll-up record. These subsequent changes should not be overwritten when the incentives are saved again.
CPQ-13730	Promotion is getting applied for inactive coupons.
CPQ-14443	If option End Date is less than bundle End Date, on reprice bundle End Date changes and becomes equal to option End Date.
CPQ-15170	When you add ramp with a price escalator, the added price ramp lines take up the base price of previous ramp line rather than latest one.
CPQ-15364	When you remove multiple records for Related Price Line Item (To) related list on a PLI, the corresponding entries are not removed from Custom Settings > Config Related Pricing Group Fields .
CPQ-15521	When you use the CSR flow with Asset Manager button in an account record to view the Installed Products page, the service catalog is displaying zero products under the Relate tab.

CPQ-33607	If you manually select mandatory options after deselecting them, Apttus CPQ displays optional checkbox. Ideally, Apttus CPQ hides optional checkboxes for mandatory options.
CPQ-33710	With Allow Manual Adjustment set to False, Apttus CPQ did not allow you to apply adjustment through "multiple adjustment" pop-up.
CPQ-34041	All the cart columns are not correctly visible on the cart grid when you use Internet Explorer 11. Note that IE 11 is not supported in this release.
CPQ-34290	<p>When you click Multiple Adjustments pop-up, but without doing anything you just close the pop-up, then reprice action becomes active. Now if you click Finalize before clicking Reprice, Apttus CPQ shows a price pending error.</p> <p>Workaround: Click Reprice to get rid of price pending error before clicking Finalize.</p>
CPQ-34562	If you set the config system property Enable Base Price Adjustment to True, Net Adjustment % gets impacted by automated price adjustments applied by Price Rule Sets.
CPQ-34773	Product sequence on cart is getting changed post collaboration request merge action.
CPQ-34774	Deal guidance pop-up does not open when the cart is opened in grouped mode.
