Fixed Issues

The following issues are fixed in this release. If any actions are required, they will be listed in this table.

Case Number	Conga Internal ID	Description
00892403	CPQ-84430	The product configuration page doesn't load when accessed via a direct URL. It should work the same as when accessed through the catalog page.
00894588	CPQ-83738	Adding a new bundle to a cart with existing bundles causes txnPrimaryLineNumber to start at 100001 instead of the next number. Incentives should apply to the line item with the lowest primary line number.
00889827	CPQ-82722	When attempting to create a cart with more than 23 bundles, an Apex heap size error occurs.

Known Issues

The following unresolved issues are known to Conga at the time of this release.

Conga Internal ID	Description
CPQ-84165	CPQ does not trigger the constraint rule upon adding a new asset to an existing service quote line.
CPQ-83435	Clicking "update all" on the Bundle Maintenance page and then refreshing causes an error. This prevents the page from opening. <code>Error: Apex CPU time limit exceeded.</code>
CPQ-83072	Auto Renew Ramp incorrectly renews the first ramp based on the 364-day Renewal Lead Time. This results in renewal opportunities and proposals with incorrect start and end dates for 2027-28.
CPQ-82733	Dates for options within a sub-bundle are incorrect upon cancellation during renewal. This issue affects the accuracy of renewal details.
CPQ-81741	Resolved high-severity issues, including Sharing Violation flags, identified in Conga upgrade packages from a recent Checkmarx scan.
CPQ-81739	Resolved high-severity issues, including CSRF, identified in Conga upgrade packages from a recent Checkmarx scan.
CPQ-81131	Attachments under Email message record linked to Quote are not visible in the "Attachments" related list on sending the proposal via email.
CPQ-77538	The cart page removes the validation error message after some time even if the condition is not satisfied.
