| CPQ-82722 | When attempting to create a cart with more than 23 bundles, a heap size error occurs. |
| CPQ-82525 | You encounter "updateCartLineItems" error after updating the product attribute in the cart. |
| CPQ-81482 | When creating a Quick Quote from an opportunity, refreshing the URL triggers the unintended creation of duplicate proposal records. |
| CPQ-81131 | Attachments under Email message record linked to Quote are not visible in the "Attachments" related list on sending the proposal via email. |
| CPQ-80001 | When the product scope contains Bundle Options and Standalone with the Include (And) option, the promotion type 'Buy X Get Y' does not work as intended. |
