New Features and Enhancements

The following features are new to Conga CPQ in this release.

Resolution of Flagged High-Severity Issues in Conga Upgrade Packages

In a recent Checkmarx scan, high-severity issues were found in multiple packages related to a Conga upgrade.

Urgent attention was needed to clarify flagged high-severity issues as potential false positives for resolution, which has now been achieved.

Fixed Issues

The following issues are fixed in this release. If any actions are required, they will be listed in this table.

pstc-3091	CPQ-83077	When clicking on the Service Wrench icon, system displays the error.
		Error - Could not resolve remote action: getServiceAssetsForLine
00891864	CPQ-83045	The changes made in the usage price tiers on the cart page are getting reverted automatically.
cpq-81706	CPQ-82321	When a currency with more than three decimal places was selected, net price data wrapped, resulting in inconsistent alignment of Net Price From and Net Price To fields.
00887122	CPQ-82057	When "Allow Manual Adjustments" was disabled in bundle configurations and the bundle was ramped in the cart, manual adjustments for options were unexpectedly enabled. However, without ramps, manual adjustments for options were disabled as expected.

Known Issues

The following unresolved issues are known to Conga at the time of this release.

Conga Internal ID	Description
CPQ-82722	When attempting to create a cart with more than 23 bundles, a heap size error occurs.
CPQ-82525	You encounter "updateCartLineItems" error after updating the product attribute in the cart.
CPQ-81482	When creating a Quick Quote from an opportunity, refreshing the URL triggers the unintended creation of duplicate proposal records.
CPQ-81131	Attachments under Email message record linked to Quote are not visible in the "Attachments" related list on sending the proposal via email.
CPQ-80001	When the product scope contains Bundle Options and Standalone with the Include (And) option, the promotion type 'Buy X Get Y' does not work as intended.
