Connection Manager

The Spring 2018 release of X-Author Contracts for Cloud is introducing the Connection Manager feature. You can save your Contract Management instances in Microsoft Word, after changing the corresponding manifest files, using **Manage Connections**. You can save your connections with the hostname and use them for connecting to Contract Management on subsequent logins.

Update from CLM

If you change field values in an agreement record after you've generated the document for that agreement and want to update the agreement document with the latest values for smart and updatable fields, you can use the new **Update from CLM** button on the X-Author for Contracts ribbon.

Open in CLM

Create Offline Agreement

Using create offline agreement feature, you can use third-party documents to create a new agreement record and bring it into the Apttus contract repository. Offline agreements are the agreement documents created outside the Salesforce CRM. Creating an offline agreement creates a new agreement record in Apttus CLM and it can be accessed you can access it from Contract Management.

Import Offline Agreement

X-Author Contracts for Cloud is introducing the Import Offline Agreement feature to import third-party documents into the Apttus contract repository and associate it with an existing agreement record. Offline agreements are the agreement documents created outside the Azure CRM. Unlike creating offline agreement, if you import an offline agreement it does not create a new agreement record but, you can access the imported document from the Documents related list of the associated agreement record in Contract Management.

XAJS-1333	When attempting to log in, if the user profile does not have a phone number, an object reference error is thrown.
XAJS-1327	After inserting a clause into an agreement and checking, the Agreement Clause related list is not populated with "Original Clause" content.
XAJS-1237	When document agreement protection is set to "Insert Comments and Track Changes Only", Mark Field does not work properly.
XAJS-1223	PDF documents are displayed in the List Agreements tabs. Only Word documents should be displayed.
XAJS-1090	After checking in an agreement document as final with "Create PDF" selected, text in the generated PDF still contains redlines.
