Enhancements to the Revenue Console

Apttus Revenue Management is now enhanced to run multiple batch jobs to accommodate a large number of Agreement records. When you click Generate Actuals or Generate Forecast button from the Revenue Console, multiple batch jobs are submitted simultaneously to manage revenue for all the agreement records present in your Salesforce Org.
