NA	<p>Based on customer business rules, users used a rebate callback to prorate and it was working fine. But when users created a rebate callback test class and executed it, a compile error occurred such as a variable (Apttus_Rebate_CustomClass.Parameters.ExtOrderAdjitemsByPayoutId) was not visible due to a protected method.</p> <p>This issue is now resolved.</p>	REBATE - 416
NA	<p>Customers used rebate tiers by using Adjustment Type = Benefit Amount and Rebates Management created incentive adjustment items records in this case.</p> <p>Rebates Management did not link these incentive adjustment records with external orders so it was not possible to prorate, based on individual external order start and end dates. You had to have the linkage of external orders on incentive adjustment line items and this had to be available on rebate callback to fulfill the requirement.</p> <p>The "Adjustment Applies To" field was required on incentive adjustment line item, such as external order adjustment line item to apply on list price or net price.</p> <p>This issue is now resolved.</p>	REBATE - 415
NA	<p>When you activated an agreement, rebate start and end dates had to match with agreement start and end dates. If the dates did not match, there was an error.</p> <p>This issue is now resolved.</p>	REBATE - 409
NA	<p>For rate per tier rebates, UOM conversion was not working. The correct tier was not selected for the converted quantity.</p> <p>This issue is now resolved.</p>	REBATE - 402
