Go to <b>System Permissions</b> and select to check <b>API Enabled</b>.</li><li>4. Click <b>Save</b>.</li></ol> <div data-bbox="407 785 1456 892" style="border: 1px solid #f9e79f; padding: 5px;"><p> Everytime you assign Apttus Ecommerce permission set to a user, you <b>MUST</b> assign Apttus Ecommerce Custom permission set as well.</p></div>
