N/A	DC-3369	Repricing the cart changed all the line status instead of just the changed line item.
N/A	DC-3100	The pricing status of an existing cart displayed <i>Pending</i> instead of <i>Updated</i> upon adding a product to the cart.
N/A	DC-2553	Asset icons and ABO actions were not displayed for a logged in user on the product card.

DC-2734	<p>Logging in to Digital Commerce fails if API Permission is disabled.</p> <p><b>Workaround:</b></p> <ol style="list-style-type: none"><li>1. Clone Apttus Ecommerce permission set and name it Apttus Ecommerce Custom.</li><li>2. Go to <b>Setup &gt; Administration Setup &gt; Manage Users &gt; Permission Sets</b> and select the permission set. In this case, Apttus Ecommerce and Apttus Ecommerce Custom.</li><li>3. Go to <b>System Permissions</b> and select to check <b>API Enabled</b>.</li><li>4. Click <b>Save</b>.</li></ol> <div data-bbox="400 786 1425 898" style="border: 1px solid #f9c94d; padding: 5px;"><p> Everytime you assign Apttus Ecommerce permission set to a user, you <b>MUST</b> assign Apttus Ecommerce Custom permission set as well.</p></div>
