Feature Summary

This release introduces the following updates

Enhancement to the System Property - Profiles Enabled for Finalize

Apttus DocuSign introduces two new system properties, Profiles Enabled for Finalize 2 and Profiles Enabled for Finalize 3. These system properties work in conjunction with the existing system property, Profiles Enabled for Finalize. The character limit for the text box of all three system properties is 255 characters each. All the three system properties provide a total character limit of **765 characters**. Using these two new system properties, the system administrator can overcome the salesforce limitation of 255 characters limit and register more user profiles. The registered user profiles can use the **Finalize in DocuSign** feature.
