## **Issues Resolved**

- The MFTS parameter successfully updates the standard Type field on the Account object upon completing a merge process. Previously, The MFTS parameter previously generated an error message and did not update the Type field on the Account object as expected.
- Composer solutions integrated with Box now authorize Box credentials with the running user's credentials, as opposed to the static Box credentials set in Conga Composer Setup. Authorization is now executed in a pop-up window after the running users clicks Merge & Box in the Composer user interface. This change results in the Box file being created and saved by the running user, instead of the user whose Box credentials are set in Conga Composer Setup.
  - Additionally, the &SC1=box parameter value no longer produces an error with the change to Composer's Box authorization.
